MINUTES OF THE REGULAR MEETINFG OF THE BOARD OF COUNTY COMMISSIONERS

CLARK COUNTY

June 12, 1989

The Board met this day in regular session. Present were Commissioners J. Albert Laird, George H. Whittaker, Charles R. Vadnais, Prosecuting Attorney Jack G. Voshell and Clerk Jo Ann S. Tavenner.

MINUTES

Motion by Commissioner Vadnais, seconded by Commissioner Whittaker unanimous that the minutes of the last regular meeting on May 8, 1989 be approved as written.

ROAD & BRIDGE UP-DATE

Kelly Bates, Road & Bridge Supervisor, met with the Commission to up-date them on Road & Bridge activities. The group discussed conditions, priorities, seal coating & repairs needed on Highway 91 north & south of town, Monteview road, road one mile north from Idmon corner, in Kilgore, the possibility of placing slow signs on this road to slow logging trucks down, if they don't work load limits would be put on.

Bates reported that the 1984 GMC truck would be delivered on June 15 or 19th and that they would be needing a radio put in it. He said that he had been talking to Craig King and that Teton Communications reported that the county would need to get a new repeater station in the near future which would cost around \$5000.00; it was suggested that the Road & Bridge, Sheriff's Department, School and Civil Defense which use the repeater most all go together and share the cost.

Bates also informed the Commission that the pickups they are driving are in bad shape, but the value of the vehicle is only around \$300 does the Board want to put money in these vehicles or replace them. No decision made at this time.

KILGORE EAST ROAD RS-6805(1) CONCEPT APPROVED

Clinton Kingsford, County Engineer, met with the Commission pertaining to progress on the Kilgore East Road RS-6805(1); Kingsford said he was requesting the surface to be 26 feet in lieu of 28 feet section originally approved. This would be two 13' lanes instead of two 14' this would fit bridges already designed. He said the structure at Spring Creek has already been designed for 28'8" curb to curb and with the one 1'4" clearance required on each side by the bridge standards, the design of this structure would not have to be changed. On East Camas Creek and Ching Creek he requested a design exception from the original design for 30'0" rail to rail and 33'8" out to out has been lengthen to 42' with no guardrail could be justified on this low volume road.

After a short discussion it was unanimous that Commissioner Laird sign the request for revision. Kingsford also informed the Board that they need to obtain a gravel source for this project he suggested that if possible that the gravel from the Thomas Vadnais pit. He said that the gravel in the Robinson pit was to fine and lava can not be used in plant mix. Commissioner Vadnais will talk to Thomas Vadnais.

The group discussed closing the Railroad & Pleasant Valley bridges. Kingsford advised closing both. he stated that we need to advertise and have a public hearing on both bridges before closing. No decission made.

BEER LICENSES APPROVED

The Board reviewed a beer licenses application received from the Clark County Rodeo Assocation. Motion by Commissioner Whittaker seconded by Commissioner Vadnais unanimous that application is hereby approved and licenses to be issued.

APPROVAL OF OVER SIXTY-FIVE EXEMPTION

Betty Kirkpatrick, County Assessor, submitted eleven requests for Circuit Breaker reductions to the Board. After reviewing the applications, it was unanimous that the applications be accepted and forwarded to the State Tax Commission for approval or rejection.
